<u>President Debbie Flick:</u> A motion to approve October 20, 2022 minutes was called by Donna Martello. The motion was seconded by Diane Fanucci. The October 20, 2022 Minutes were unanimously approved.

<u>Supervisor of Officials Donna Martello</u>: The grievance committee of Kathy Yeager, Patty Connor and Megan Stielau brought forth concerns from the chapter regarding:

- Assigning procedures. More equitable distribution of games.
- State tournament/Playoff assignments.
- Cadets working alone. Whenever possible, an experienced official should be assigned to work with the cadet.
- Limit the number of times an official sees a team.
- Compensation for downtime between JV and Varsity games. ie: 4pm and 6pm.
- Use of Communication devices- phones or radios- at all levels.
- Reassigning rainouts utilizing the "postponement" feature on Zebraweb.
- Discontent with officials who are unsporting toward fellow officials while they are a parent/fan at a game.
